

MINDJET MINDMANAGER MAPSHARE END USER LICENSE AGREEMENT

This Mindjet® MindManager MapShare™ End User License Agreement (the “**EULA**”) is an agreement between you and the Mindjet affiliate applicable to you. Please read them. They apply to the Software that accompanies these license terms, which includes the media on which you received it, if any. The terms also apply to any Mindjet updates, supplements and support services for this Software, unless other terms accompany those items. If so, those terms apply.

The Mindjet entity that is applicable to you depends on where you maintain your primary residence:

Europe (excluding the UK and Ireland), the Middle East or Africa:	Mindjet GmbH
UK or Ireland:	Mindjet (UK) Ltd.
Japan:	Mindjet Co. Ltd. (KK)
Anywhere else, including the United States:	Mindjet LLC

BY USING THE SOFTWARE, YOU ACCEPT THESE TERMS. IF YOU DO NOT ACCEPT THEM, DO NOT USE THE SOFTWARE. INSTEAD, IF THE SOFTWARE WAS NOT PROVIDED TO YOU FREE OF COST OR AS A TRIAL, RETURN IT TO MINDJET OR THE RETAILER IMMEDIATELY FOR A REFUND OR CREDIT.

IF YOU COMPLY WITH THESE LICENSE TERMS, YOU HAVE THE RIGHTS BELOW FOR EACH LICENSE YOU ACQUIRE.

1. OVERVIEW. These license terms permit installation of one (1) production instance and one (1) non-production instance (which includes instances for development, testing, staging, hot-backup, and/or quality assurance) of MindManager MapShare (the “**Software**”) on each of the licensed number of Front-End Servers (as defined below) for the use up to one thousand (1,000) Named Users (as defined below) per Front-End Server, as set forth in your ordering document (e.g., quote, invoice, Online Store Cart,), along with other rights, as described below for your subscription period. Your rights to use the Software are limited to the subscription period. Your subscription period commences upon delivery of the Software to you, not from the date of installation and acceptance of this EULA. You may have the option to extend your subscription or convert to a perpetual license. If you extend your subscription, you may continue using the Software until the end of your extended subscription period. After the expiration of your subscription, you are legally obligated to discontinue your use of the Software and uninstall it. A **Front-End Server**, as used herein, shall mean a Microsoft® SharePoint® Server within a SharePoint web farm that accepts requests from clients and proxies them to the appropriate back-end SharePoint server for processing. Depending on your environment architecture, a Front-End Server may be a Server or a Virtual Machine. A **Server**, as used herein, shall mean a single physical computer of a type that meets the specifications as set forth in the applicable product documentation. Multiple computers that share processing power or operate in a networked configuration as a single logical computer, such as a “SharePoint web farm”, “server farm” or similar arrangement, constitute multiple Servers for the purposes of this EULA. A **Named User**, as used herein, shall mean an end user with a unique log-in and password to access the SharePoint application and use its functionality. A **Virtual Machine**, as used herein, shall mean an instance of a third-party operating system and any application programs installed thereon, licensed by you and running on a computing device on which the Software is installed, or suspended to disk, or any other storage media accessible by the computing device.

2. **INSTALLATION AND USE RIGHTS.** Subject to the terms of this EULA, Mindjet hereby grants you a non-exclusive, non-transferable license, without rights to sublicense, use of the object code of the Software for your internal business purposes in conjunction with Microsoft SharePoint software only, subject to the technical restrictions of the Software and/or any additional licensing terms specified by Mindjet via product documentation, notification, and/or program or policy change for the term set forth in your ordering document. You may use the documentation accompanying the Software in connection with the foregoing permitted use of the Software.

3. **ADDITIONAL LICENSING REQUIREMENTS AND USE RIGHTS.**

a. **Third Party Software Licenses.** The Software is a module that is used in conjunction with Microsoft SharePoint. You are responsible for obtaining and complying with any licenses necessary to operate Microsoft SharePoint for which you have paid the applicable license fee and accepted any applicable additional license terms.

b. **Trial and Conversion.** The Software may be licensed on a trial basis for your internal business evaluation and trial purposes only. Your rights to use trial Software are limited to a thirty (30) calendar day trial period (the "**Trial Period**") which shall commence upon delivery of the Software, not from the date of installation and acceptance of this EULA. Notwithstanding Section 1 (Overview), you may install on an unlimited number of Front End Servers for use by an unlimited number of Named Users, as reasonably necessary, to evaluate the Software. Notwithstanding the Limited Warranty section and the Limited Warranty for Users Residing in a Member State of the European Community section, any Software provided to you on a trial basis is provided AS IS, without warranty, WHETHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, QUIET ENJOYMENT, AND NONINFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS. MINDJET HAS NO LIABILITY FOR ANY DAMAGES RESULTING FROM USE (OR ATTEMPTED USE) OF THE SOFTWARE DURING AND AFTER THE TRIAL PERIOD. You may have the option to convert your trial rights to subscription or perpetual rights. Conversion options may be presented to you at the expiration of your trial period. After the expiration of any trial period without conversion, you must discontinue your use of the Software and delete the Software from any Front-End Servers and certify such destruction in writing to Mindjet, upon request.

c. **IPL/EMEA 5Plus Program.** If you licensed the Software pursuant to special terms and conditions of a marketing and/or sales promotion in your geographic sales region, those terms shall supersede the conflicting terms of this EULA only with regards to: (i) the licensing entity; (ii) the length of term or subscription period; (iii) the number of instances per Server, copies, and Named Users provided per license grant; and (iv) if, and when, Mindjet makes any updates or upgrades to the Software available to you or your Affiliates. All other provisions set forth in such marketing and/or sales promotion shall continue in effect provided that those provisions set forth herein shall govern in the event of any conflict between this EULA and such special terms and conditions.

d. **Reporting.** During the term of this agreement, you will provide upon request of Mindjet a report of the number of installed instances of Software and the number of Named Users with access to your SharePoint environment. Mindjet may request such a report at most once a calendar year.

e. Audit Right. Mindjet may audit at its own expenses your compliance with regards to the use rights of the Software. The auditors will be appointed by Mindjet. Such an audit may only be performed once a calendar year during normal business hours in your place of business and may not unreasonably affect your operations. If the audit proves your noncompliance with the use right set forth herein, Mindjet will invoice you for any noncompliance Software licenses at the rate of the then-current Mindjet end user price list. If the number of non-compliant Software licenses exceeds 5% of the total amount of licenses reported by you, the reasonable costs for the audit shall be borne by you.

4. **SCOPE OF LICENSE**. The Software is licensed to you, so this agreement only gives you some rights to use it. Mindjet reserves all other rights. Unless applicable law gives you more rights despite this limitation, you may use the Software only as expressly permitted in this agreement. You may not:

- work around any technical limitations in the Software;
- reverse engineer, decompile or disassemble the Software, except and only to the extent that applicable law expressly permits;
- make more copies of the Software than specified in this agreement or allowed by applicable law;
- publish the Software for others to copy;
- use the Software in any way that is against the law;
- rent, lease or lend the Software; or
- use the Software for commercial Software hosting services.

Mindjet retains all right, title, and interest in and to the Software and in all related copyrights, trade secrets, patents, trademarks, and any other intellectual and industrial property and proprietary rights, including registrations, applications, renewals, and extensions of such rights.

5. **COLD BACKUP COPY**. You may make one (1) cold backup copy of the media. You may use it only to reinstall the Software.

6. **DOCUMENTATION**. Any person that has valid access to your computer or internal network may copy and use the documentation for your internal, reference purposes.

7. **UPGRADE OR CONVERSION**. To upgrade or convert Software, you must first be licensed for the Software that is eligible for the upgrade or conversion. Upon upgrade or conversion, this agreement takes the place of the agreement for the Software you upgraded or converted from. After you upgrade or convert, you may no longer use the earlier version of the Software you upgraded or converted from.

8. **EXPORT RESTRICTIONS**. The Software is subject to United States export laws and regulations. You must comply with all domestic and international export laws and regulations that apply to the Software. These laws include restrictions on destinations, end users, and end use.

9. **SUPPORT SERVICES**. It is your responsibility to install and deploy the software. Mindjet provides free online support services for the software as described at www.mindjet.com/us/support/support_center/index.php. You will also be provided up to two support inquires/incidents regarding the Software during your Trial Period and up to an additional six support inquiries/incidents regarding the Software per year during your initial and renewal subscription term(s) or

license term, commencing on the date of delivery of the Software, at no charge. Thereafter, support inquiries/incidents are subject to then-current time and materials rate for support. The scope of support services is limited to installation and use of the Software. Technical support, configuration, installation, and use of Microsoft SharePoint is explicitly excluded. Updates and upgrades to the Software shall be provided to you as Mindjet makes such updates and upgrades generally available. Any updates, supplemental software code, or related materials that Mindjet provides to you as part of any support and subscription services are to be considered part of the Software and are subject to the terms and conditions of this EULA. If Mindjet provides you with any upgrades, you will be licensed to use each upgrade in place and instead of the version of the Software that was upgraded. After an upgrade is installed, the license to use any previous versions of the updated Software is suspended. This EULA does not give you any rights to any updates or upgrades to the Software or to any extensions or enhancements to the Software developed by Mindjet at any time in the future. Mindjet's support services for the Software, including both online and telephone support, are subject to separate terms and conditions. Any supplemental software code or related materials that Mindjet provides to you as part of any support services are to be considered part of the Software and are subject to the terms and conditions of this EULA. Mindjet may use any technical information you provide to Mindjet for any Mindjet business purposes without restriction, including for product support and development. Mindjet will not use information in a form that personally identifies you. Notwithstanding the foregoing, Mindjet has no duty to provide support to you during your use of the Software during any trial period.

10. **TERMINATION.** Mindjet may terminate this EULA immediately and without notice if you fail to comply with any term of this EULA. In the event of termination, you must destroy all copies of the Software. In addition you must remove all copies of the Software, including all backup copies, from the Virtual Machine and/or Server and all computers and terminals on which it is installed. From time to time, Mindjet may change the terms of this EULA. Mindjet will notify you of such change. Your continued use of the Software will indicate your agreement to the change.

11. **ENTIRE AGREEMENT.** This agreement (including the warranty below), any addendum or amendment, and the terms for supplements, updates, Internet-based services and support services that you use, are the entire agreement for the Software and support services.

12. **GOVERNING LAW.** If you obtained your license in Europe (excluding the UK and Ireland), the Middle East or Africa, this agreement shall be governed by the laws of Germany. If you obtained your license in the United Kingdom or Ireland, this agreement shall be governed by the laws of the United Kingdom. If you obtained your license in Japan, this agreement shall be governed by the laws of Japan. If you obtained your license anywhere else, these Terms shall be governed by the laws of the State of California. This agreement will not be governed by the conflict of law rules of any jurisdiction or the United Nations Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded.

13. **LEGAL EFFECT.** This agreement describes certain legal rights. You may have other rights under the laws of your state or country. You may also have rights with respect to the party from whom you acquired the Software. This agreement does not change your rights under the laws of your state or country if the laws of your state or country do not permit it to do so.

14. **LIMITATION ON AND EXCLUSION OF DAMAGES.** YOU CAN RECOVER FROM MINDJET AND ITS RESELLERS ONLY DIRECT DAMAGES UP TO THE AMOUNT YOU PAID FOR THE SOFTWARE. YOU CANNOT

RECOVER ANY OTHER DAMAGES, INCLUDING CONSEQUENTIAL, LOST PROFITS, SPECIAL, INDIRECT OR INCIDENTAL DAMAGES. This limitation applies to (i) anything related to the Software, services, content (including code) on third party Internet sites, or third party programs, and (ii) claims for breach of contract, breach of warranty, guarantee or condition, strict liability, negligence, or other tort to the extent permitted by applicable law. It also applies even if (i) repair, replacement or a refund for the Software does not fully compensate you for any losses, or (ii) Mindjet knew or should have known about the possibility of the damages. Some countries and states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

15. LIMITED WARRANTY. Except with respect to the trial version, Mindjet warrants that the Software shall perform substantially as described in its documentation, as set forth in the Software's Installation Guide and Online Help, for a period of sixty (60) days from purchase unless otherwise required by applicable law. Your sole remedy in the event of a breach of this warranty will be that Mindjet will replace any defective media returned to Mindjet within the warranty period. THE ABOVE WARRANTY APPLIES ONLY TO THE SOFTWARE, AND NOT TO THE TRIAL VERSION, AND IS EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, QUIET ENJOYMENT, AND NONINFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS.

16. DEPLOYMENT, ASSIGNMENT, TRANSFER. Mindjet may assign this agreement in whole or in part. You may deploy the Software within your legal entity and any of your Affiliates (defined below) provided that: (i) such deployment is made only within the region in which you purchased the Software (see the second paragraph of this agreement for a description of the applicable regions) and (ii) the Affiliate at which the Software is deployed accepts and agrees to comply with all of the terms and conditions of this agreement. Any attempt to deploy Software or assign this agreement in violation of this Section shall be void. Subject to the foregoing, this agreement will be binding upon and will inure to the benefit of the parties' permitted successors and assignees. You may assign all of your rights under this agreement to use the software and may thereafter transfer the software to another person or legal entity that is not an Affiliate provided that: (i) such transfer is a result of your transferring rights and title in and to the computer on which the software is installed, (ii) the transfer is only made within the applicable region in which the software was purchased, (iii) you also transfer this agreement and the software and all other software or hardware bundled with the software as acquired by you, including all copies, updates, and prior versions to such person or entity and (iv) the transferee accepts and agrees to comply with all of the terms and conditions of this agreement. For purposes of this agreement, an "Affiliate", with respect to your legal entity, shall mean another legal entity that controls, is controlled by, or is under common control with, your legal entity. "Control" for this purpose shall mean 50% or greater voting power.

17. PUBLICITY. Mindjet may use your corporate logo on client lists in various forms (e.g., a printed list, an online list, etc.) and in other marketing materials, for the sole purpose of identifying you (or your employer, as the case may be) as a customer of Mindjet. In any use of your logo, we will comply with any logo usage guidelines that you may provide and we will promptly fix any defect that you bring to our attention. Mindjet may use your name, logo, website link, quote, and any other information that you may provide to develop case studies, press releases, and other marketing pieces in any form (e.g., print, audio, video, and other formats) that pertain to your use of Mindjet products or services. Mindjet may publish and freely distribute all such

information, quote(s) or input. Mindjet will never broadly publish your individual contact information (i.e., it will not appear on our customer list or in a case study) without your prior written consent. Mindjet is not obligated to publish or otherwise use any information or logo that you may provide. The rights that you grant to Mindjet are without any fee or royalty.

18. SPECIAL PROVISIONS FOR RESIDENTS OF MEMBER STATES OF THE EUROPEAN ECONOMIC COMMUNITY.

a. Limitation of Liability for Users Residing in a Member State of the European Community. If you obtained the Software in a Member State of the European Community, and you usually reside in such a country, then Limitation on and Exclusion of Damages section does not apply. Instead, except as provided in this paragraph, Mindjet's statutory liability for damages shall be limited as follows: (i) Mindjet shall be liable only up to the amount of damages as typically foreseeable at the time of entering into the purchase agreement in respect of damages caused by a slightly negligent breach of a material contractual obligation and (ii) Mindjet shall not be liable for damages caused by a slightly negligent breach of a non-material contractual obligation. The aforesaid limitation of liability shall not apply to any mandatory statutory liability, in particular, to liability caused by wrongful intent or gross negligence, to liability under the German Product Liability Act, liability for assuming a specific guarantee or liability for culpably caused personal injuries. You are required to take all reasonable measures to avoid and reduce damages, in particular to make back-up copies of the Software and your computer data subject to the provisions of this agreement.

b. Limited Warranty for Users Residing in a Member State of the European Community. If you obtained the Software in a Member State of the European Community, and you usually reside in such a country, then the Limited Warranty section does not apply. Instead, Mindjet warrants that the Software provides the functionalities set forth in the accompanying documentation in the Software's Installation Guide and Online Help (the "agreed upon functionalities") for the limited warranty period following receipt of the Software when used on the recommended hardware configuration. As used in this sub-section, "limited warranty period" means one year if you are a business user and two years if you are not a business user. Non-substantial variation from the agreed upon functionalities shall not be considered and does not establish any warranty rights. THIS LIMITED WARRANTY DOES NOT APPLY TO SOFTWARE PROVIDED TO YOU FREE OF CHARGE, FOR EXAMPLE, UPDATES, PRE-RELEASE, TRIAL, VIEWER, OR SOFTWARE THAT HAS BEEN ALTERED BY YOU, TO THE EXTENT SUCH ALTERATIONS CAUSED A DEFECT. To make a warranty claim, during the limited warranty period you must return, at our expense, the Software and proof of purchase to the location where you obtained it. If the functionalities of the Software vary substantially from the agreed upon functionalities, Mindjet is entitled – by way of re-performance and at its own discretion – to repair or replace the Software. If this fails, you are entitled to a reduction of the purchase price (reduction) or to cancel the purchase agreement (rescission).

c. Assignment, Transfer for Users Residing in a Member State of the European Community. If you obtained the software in a Member State of the European Community, and you usually reside in such a country, then the limitations in clauses (i) and (ii) of the third sentence of Section 16 (pertaining to transfer of the software) shall not apply to you.
